

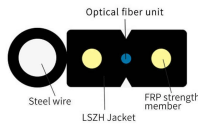
## FOB price CFP2QSFP



### Overview

Use this formula:  $\text{FOB Price} = \text{Product Cost} + \text{Packaging} + \text{Inland Freight} + \text{Export Fees} + \text{Loading}$ . Let's walk through a real-world fob pricing example for 100 widgets from China to the US. FOB (Free On Board), which is often called "FOB Shipping Point" or "FOB Port of Shipment," is one of the most used Incoterms in international trade. The seller is responsible for all costs and hazards until the items are put onto the ship at the port of shipment, according to FOB agreements. 50 per unit, most first-time importers assume that is what they will pay. FOB price is a starting point, not a final cost.

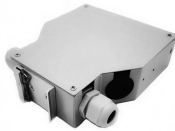
