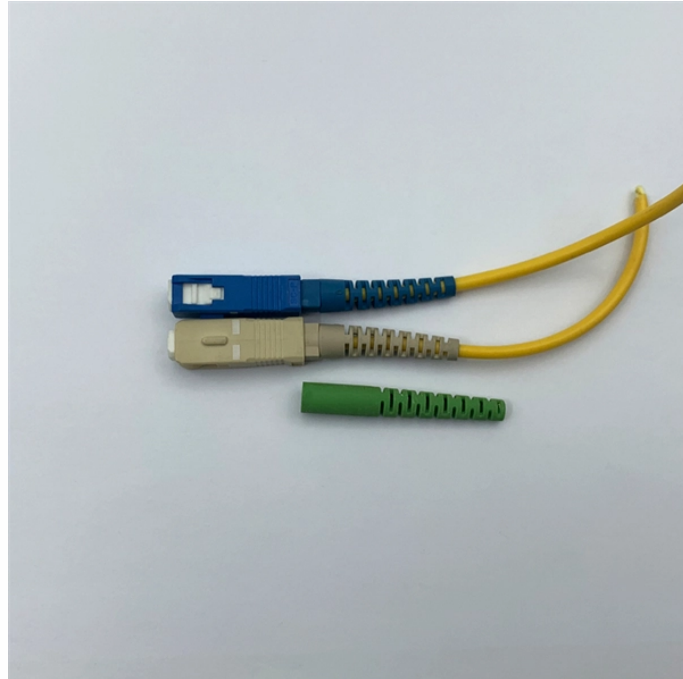


Ireland Secondary Distribution Box Bracket



Overview

The Secondary Distribution Box (SDB) receives power from Main Power Distribution box via an extender cable and provides a central power distribution to feed normal branch circuits to the electric floor modules through snap-on extender cables. Primary Income is income from production (sales of goods and services), from capital investment (interest on loans, dividends on shares, and similar income), and from labour (wages and other benefits). 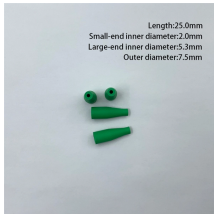

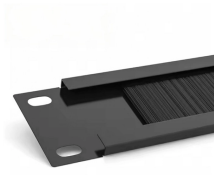

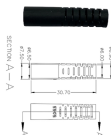
