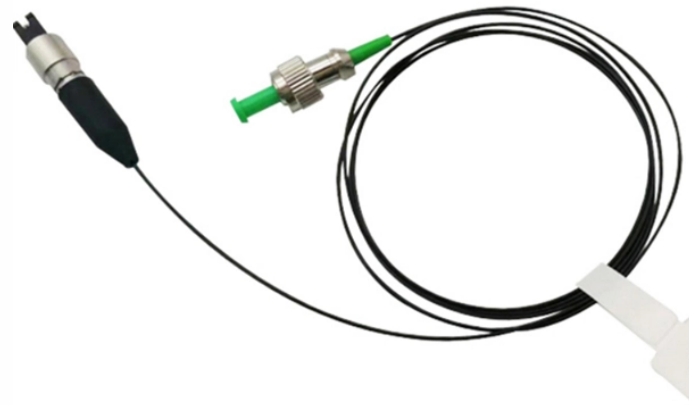


Israeli Cold Bonding

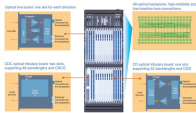

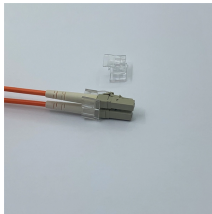
