

Qualification Requirements for Optical Cable Bidding

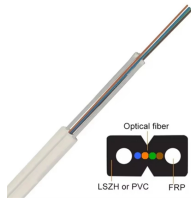


Overview

The terms and requirements in the Act and Regulations govern the submission of Bids and should be read by all Bidders.
