Federal law defines broadcasting as the transmission of radio signals intended for reception by the general public, and the Federal Communications Commission regulates every step of the process from licensing a station to what it can air. The FCC's authority covers spectrum allocation, ownership. (1) TV licensees or permittees that broadcast in ATSC 1.0 (using the transmission standard in 73.682 (d)) shall transmit at least one free over the air video program signal at no direct charge to viewers.
